a. Review of 5th Cycle Water Planning schedule

Dexter May with Plummer discussed the Planning schedule for remainder of the 5th cycle.

- b. County Review: Angelina, Henderson, Nacogdoches, Orange and Rusk Counties Jordan Skipwith, Freese & Nichols.
 - Angelina County:
 - Steady population growth
 - Primary water use is municipal
 - Total developed supply greater than total demand
 - o No municipal WUGs with identified needs
 - Manufacturing and mining with identified needs
 - o Strategies include purchasing additional supply from Lufkin and ANRA
 - Henderson County:
 - Steady population growth
 - Primary water use is municipal
 - Total developed supply greater than total demand
 - o WUGs identified with needs: Chandler, Moore Station WSC, mining
 - Municipal conservation, purchase water from Tyler for Chandler
 - Strategies to develop groundwater supplies in Carrizo-Wilcox for Moore Station WSC and mining
 - Nacogdoches County:
 - Steady population growth
 - Primary water uses are municipal and livestock

- Projected demand approximately equal to developed supply
- WUGs identified with needs: Cushing, D&M WSC, Livestock, and Mining
- Strategies include municipal conservation, additional wells in Carrizo-Wilcox Aquifer, purchase additional water from ANRA
- Orange County:
 - Steady population growth
 - Primary water uses manufacturing and municipal
 - Almost all supply is developed
 - Total developed supply significantly exceeds demands
 - o Irrigation users identified with needs, strategy to purchase supply from SRA
- Rusk County:
 - Increasing population growth
 - Primary water uses are steam electric power and municipal
 - Total demand exceeds total supply
 - Multiple users identified with needs
 - Strategies to develop groundwater supplies in Carrizo-Wilcox for Jacobs WSC, Wright City WSC, and Livestock
 - Strategies to purchase from ANRA (mining) or SRA (SEP)

10. Consider Approval of Removal/Appointment of Voting Members – Monty Shank.

Monty Shank made recommendation from the Nominating Committee to accept the resignation of Don Iles, Public interest.

Greg Morgan made motion to accept Don Iles resignation. The motion was seconded by Roger Fussell and unanimously approved.

Monty Shank made recommendation from the Nominating Committee to replace Don Iles with Terry Stelly to represent the Public interest; and appoint David Gorsich to represent Industries.

Randy Stanton made motion to replace Don Iles with Terry Stelly to represent the Public interest; and appoint David Gorsich to represent Industries. The motion was seconded by David Alders and unanimously approved.

11. Consideration and Approval of definition of significant needs in the region – Jordan Skipwith Freese & Nichols

Process for defining significant needs for Region I:

- Identify unmet needs before WMS implementation
- Assess various numerical thresholds
 - Entities with larger needs are more likely to adopt ASR
- Constrain to municipal WUGS and WWPS
 - Most likely to sponsor ASR projects
- 5,000 Acre-Feet per Year Unmet needs threshold

David Alders moved to approve 5,000 Acre-Feet per Year of Unmet Needs as definition of significant needs in Region I. The motion was seconded by Roger Fussell and unanimously passed.

12. Consideration and Approval of the substantial completion of draft Chapter 5A – Identification of Potentially Feasible Water Management Strategies for the 2021 Region I Water Plan – Jordan Skipwith – Freese & Nichols

Stevan Gelwick made motion to approve draft 5A as presented. The motion was seconded by Josh David and unanimously approved.

13. Review of Chapter 5B Potentially Feasible Water Management Strategies – Cynthia Syvarth – Plummer

Chapter 5B is the same as 5A – no action required.

- 14. Consideration and Approval for chair to submit notice-to-proceed request for additional Task 5A funds with the following actions: Cynthia Syvarth Plummer
 - a. Approval and authorization to submit the approved notice-to-proceed request to the TWDB;
 - b. Authorization for the consultant and/or political subdivision to work with the TWDB on any follow up information that might be required; and
 - c. Authorization for the political subdivision to negotiate and execute the subsequent TWDB contract amendment that will be issued.

Scott Hall made motion to authorize the submission of the approved notice-to-proceed request to the TWDB; and authorize the consultant and/or political subdivision to work with the TWDB on any follow up information that might be required; and authorize the political subdivision to negotiate and execute the subsequent TWDB contract amendment that will be issued. 17. Consideration and Approval for the chair to enter into a contract with Shaffer Creative, LLC to redesign the Region I website – Dexter May, Plummer

Chairman Holcomb advised the board currently there is no funding on the grant side to help with the redesign of the website. He suggested the FY 2021 Administration Budget include the \$5,000 estimated to cover the website update.

John Martin made motion to authorize the City of Nacogdoches to initiate a contract through Plummer with Schaffer Creative, LLC to redesign the Region I website; and authorize a not to exceed amount of \$5,000 from local funds to cover the costs. The motion was seconded by Randy Stanton and unanimously passed.
