5. Consideration and approval of the minutes of the August 5, 2020 meeting.

Monty Shank moved the minutes of August 5, 2020 meeting be approved as presented. Greg Morgan seconded the motion and was unanimously passed.

  - a. Texas Water Development Board Lann Bookout

Lann Bookout advised regional boundaries are reviewed every five (5) years; and in October there will be an opportunity for the stakeholder input regarding boundaries. The Final Plan process (plans and prioritization list), due date of 10/14/2020 has been extended to 11/5/2020 to help facilitate data entry. Also, the requirement for copies has been waived; RWPGs need to approve FPs during a regular meeting with consideration of all comments received. The consultants need to finalize the implementation and IFR survey. The first RFA for the Sixth (6) Cycle of RWP will be issued in March of 2021. Planning groups will need to take action to select Political Subdivision and authorize them to submit an application prior to FRA deadline. Other Sixth (6) Cycle actions to be passed sometime in 2021 include: Authorize Political Subdivisions to provide a public notice and hold a preplanning public meeting to obtain public input for development of the 2026 Regional Water Plan and selection of Technical Consultants.

**16.** General Discussion – Chairman Kelley Holcomb

Chairman Kelley Holcomb discussed the Interregional Committee; and that they had met several times; and he noted their committee will submit their report in October 2020. Chairman Kelley Holcomb further stated he will step down as Chairman in February 2021. He remarked he had served as Chairman for three (3) Regional Water Plan cycles, approximately 15 years. Now he will focus on the Angelina Neches River Authority, his day job
